This Privacy Policy is intended to provide you with information on how Groupe Dynamite Inc. ("Groupe Dynamite Inc.", "we", "us", or "our") collects, uses, discloses, and protects your personal information when you use our services. This Policy applies to all interactions you may have with our website and any other services we provide.

This Privacy Policy also contains information on your rights regarding your personal information, and how you can exercise them. If you have any questions on how we handle your personal information or if you want to exercise your privacy rights, you can reach out to our Privacy Officer at any time:

**What is the Scope of this Privacy Policy?**

This Privacy Policy covers our services including:

- Our websites and other digital properties that link to this Privacy Policy;
- Our brick-and-mortar retail stores;
- Orders that we fulfill for our partners;
- Our surveys and other consumer research activities;
- Our promotions, sweepstakes, and contests;
- Our marketing activities including when you sign up for our newsletters;
- Our Groupe Dynamite Inc. Concierge service; and
- Our social media accounts.

**We refer to our activities described above collectively as the "Services".**

Our website may contain hyperlinks to services or applications, including social media sharing widgets. We provide these hyperlinks for convenience only and have no control over the privacy and confidentiality practices of third-party sites. Therefore, any personal information shared through these sites is not covered by this Privacy Policy but is subject to the site's own privacy policies. It is your responsibility to review these policies to protect your personal information.

## What is Personal Information?

Personal information means any information that, either on its own or when combined with other information, can be used to identify a natural person, either directly or indirectly. Some of the information that we consider as personal information for the purpose of this Privacy Policy may not be protected under applicable laws of other jurisdictions, and you may not be entitled to the same rights regarding such personal information.

## Your Consent

When you provide Groupe Dynamite Inc. with your personal information, you consent to Groupe Dynamite Inc.'s collection, use, disclosure, and retention of your information in accordance with this Privacy Policy and as otherwise permitted by law.

## **1. What Personal Information Does Groupe Dynamite Inc. Collect?**

**Information You Provide to Us.** Personal information you may provide to us through the Service or otherwise includes:

- **Contact Data**, such as your first and last name, email address, billing and mailing addresses, and phone number when you purchase products or services from us (including at Groupe Dynamite Inc retail stores or through the Groupe Dynamite Inc website), contact us through Groupe Dynamite Inc Customer Service, or when you create an online account with us.
- **Profile Data**, such as your username and password that you set to establish an online account with us, age, date of birth, gender, biographical details, photos, links to your profiles on various third -party sites including social networks, interests, preferences, and information about your participation in our events, promotions, sweepstakes, contests, or surveys.
- **Communications** that we exchange, or you share or publish, including when you communicate with us with questions, feedback, or otherwise, including through Groupe Dynamite Inc Customer Service, our Client Support team, and on social media, such as through direct messages or public posts. We may record our conversations, including telephone conversations. When you call us, we may use machine learning tools to help us understand if your experience is positive or not.
- **Research Data** that you provide when you agree to participate in our surveys or

research activities (including the Research Community), such as your survey responses, profession, interviews, workshops, and audio and/or video that we record about you or captures of your device's screen to collect clicks and navigation patterns, in relation to such surveys and research activities.

- **Payments and Transactional Data**, such as the information needed to complete your orders on or through the Services (including your name, credit card information, bank account number, and billing and shipping information) and your purchase history.
- **Marketing Data**, such as your preferences for receiving communications about our products, services, events, promotions, newsletters, and similar messages, and details about how you engage with our communications.
- **Job Application Data**, such as your professional credentials and skills, educational and work history, LinkedIn profile page, personal website, authorization to work in Canada, immigration status, criminal history, and other information that may be included on a resume or curriculum vitae as well as in a cover letter. This may also include diversity information that you voluntarily provide.
- **Other Information**, that we may collect which is not specifically listed here which we will use as described in this Privacy Policy or as otherwise disclosed at the time of collection.

**Third - Party Sources**, We may combine personal information we receive from you with personal information we obtain from other sources, such as:

- **Public Sources**, such as social media platforms, publications, and news sites.
- **Business and Marketing Partners**, such as marketplaces including Instagram, joint marketing partners, and event co-sponsors.
- **Data Providers**, such as information services and data licensors that provide demographic and other information about our users.
- **Users of the Services**, who can purchase products or services (including gift cards) for others, share a product or article with others, refer a friend, or otherwise share the contact information of others with us.
- **Third - Party Platforms**, including social media accounts such as Facebook, that you use and choose to connect to the Services. This data may include your username,

profile picture and other information associated with your account on that third -party service that is made available to us based on your account settings on that service.

**Automatic Data Collection.** We, our service providers, and our business partners may automatically log information about you, your computer or mobile device, and your activity over time on our sites and other sites and online services, such as:

- **Device Data**, such as your computer or mobile device operating system type and version number, manufacturer and model, browser type, screen resolution, IP address, unique identifiers, the website you visited before browsing our website, and general location information such as your city, province or geographic area.
- **Online Activity Data**, such as pages or screens you viewed, how long you spent on a page or screen, navigation paths between pages or screens, information about your activity on a page or screen, access times, and duration of access.
- **Security Camera Footage and Photos**, from our stores and offices.

**Information About Others**, . We may also collect information about you from others who know you like your family or friends such as when they want to ship a product (including gift cards) to your address. For example, to send the package, we would need them to tell us your name, email, and mailing and shipping addresses. We may also collect information about you from family or friends if they send you a link to a product or article on the Groupe Dynamite Inc. website. If you provide us with information about your family or friends, please make sure you have their consent and remind them to review our Privacy Policy which describes how we use their information.

## **2. Cookies and Similar Technologies**

Groupe Dynamite Inc.'s websites, online services, email messages, and advertisements may use "cookies" and other similar technologies, such as web beacons, pixel or GIF tags, and action tags. Those technologies collect information that assists Groupe Dynamite Inc. with improving products and services, advertising, customer communications and the shopping experience.

### **3. How Can You Manage Your Cookie Preferences?**

You can manage your cookie preferences through your browser or by withdrawing your consent on the use of cookies at any time through the Cookies Preferences option. Certain features of our website may require cookies for security purposes.

**Do Not Track:** Some Internet browsers may be configured to send "Do Not Track" signals to the online services that you visit. We currently do not respond to "Do Not Track" or similar signals. To find out more about "Do Not Track," please visit <https://allaboutdnt.com/>.

## **4. How Does Groupe Dynamite Inc. Use Your Personal Information**

We use your personal information for the following purposes or as otherwise described at the time we collect it:

**To Provide Services.** We use your personal information to:

- Provide, operate, and improve the Services and our business;
- Establish and maintain your user profile on the Services, including tracking your orders and shipments and sending you reminders of items left in your shopping cart;
- Remember devices from which you have previously logged in;
- Communicate with you about the Services, including by sending announcements, updates, security alerts, and support and administrative messages;
- Understand your needs and interests, and personalize your experience with the Services and our communications, such as by using your location information to determine your language preferences or display accurate date and time information; and
- Provide support for the Services, respond to your requests, questions, and feedback, including through Groupe Dynamite Inc. Customer Service, evaluate your satisfaction with the Services, and administer our relationship with you.

We may combine your personal information collected through various sources, including information collected at Groupe Dynamite Inc.'s retail stores and through Groupe Dynamite Inc.'s websites, and information obtained from other sources, such as to enhance and personalize your shopping experience on our websites and facilitate product returns.

**Research and Development.** We may use your personal information for internal research and development purposes, including to analyze and improve the Services and our business. As part of these activities, we may create aggregated, de-identified data from personal information we collect. We make personal information into de-identified data by removing information that makes the data personally identifiable to you. We may use this de-identified data and share it with third parties for our lawful business purposes, including to analyze and improve the Services and promote our business. For example, if we learn that most users use mobile devices, we might wish to expand on that feature.

**Marketing and Advertising.** We and our third-party advertising partners may collect and use your personal information for marketing and advertising purposes, except that such sharing with third parties does not include sharing of personal information collected through our short code text messaging programs without your consent:

- **Direct Marketing.** We may send you Groupe Dynamite Inc.-related or other direct marketing communications as permitted by law. You may opt out of our marketing communications as described in the Opt Out of Marketing Communications section.
- **Interest-Based Advertising.** We may contract with third-party advertising and social media companies to display ads on the Services and other online services. These companies may use cookies and similar technologies to collect information about you (including the device data, online activity data, and/or geolocation data described above) and your interaction over time across the Services, other online services, and with our communications, and use that information to serve ads that they think will interest you. This is called interest-based advertising. We may also share information about our users with these companies to facilitate interest-based advertising to those or similar users on other online platforms. You can learn more about your choices for limiting interest-based advertising in the Advertising Choices section.

**Advertising Analytics and Conversion Tracking.** We and our third-party advertising partners may collect your information during the checkout process when you make a purchase by way of clicking on one of our ads. More particularly, our website sends an encrypted version of the email address used for the purchase and other personal information such as name and phone number to the third-party advertising platform to help us measure the effectiveness of our advertising campaigns. The third-party advertising platform then uses this encrypted information to determine if you were shown one of our ads prior to your purchase. This process allows us to understand the performance of our ads so that we can adjust our marketing strategy accordingly. It does not provide us with any access to your social media profile through which you made the purchase, nor does it provide any other personal information beyond what you provide to us directly.

**Manage Recruiting and Process Employment Applications.** We may use personal information, such as information submitted to us in a job application, to facilitate our recruitment activities and process employment applications, such as by evaluating a job candidate for an employment activity and monitoring recruitment statistics.

**Compliance and Protection.** We may use your personal information to:

- Comply with applicable laws, lawful requests, and legal processes, such as to respond to subpoenas or requests from government authorities;
- Protect our, your, or others' rights, privacy, safety, security, or property (including by making and defending legal claims and security monitoring in our stores);
- Audit our internal processes for compliance with legal and contractual requirements and internal policies;
- Enforce the terms and conditions that govern the Services, including our Terms of Use, and

other legal terms and policies; and

- Prevent, identify, investigate, and deter fraudulent, harmful, unauthorized, unethical, or illegal activity, including cyberattacks and identity theft.

## **5. How Does Groupe Dynamite Inc. Share Personal Information with Third Parties?**

We may share your personal information with the parties below and as otherwise described in this Privacy Policy or at the time of collection.

We allow you the option to individually set your consent preferences for every partner we use to collect data. Click on a partner name to get more information on what it does, what data it is collecting, and how it is using it. You have the option to block all partners or authorize specific ones. You may access this option through the Cookie Preferences – View our Partners button.

Here are our partner categories:

**Affiliates.** Our corporate affiliates for the provision of our products and Services consistent with this Privacy Policy.

**Suppliers and Service Providers.** Companies and individuals that provide services on our behalf or help us operate the Services or our business (such as IT, hosting, payment processing services, customer relationship management and support, print and mail fulfillment, order fulfillment and shipping, data/document storage and management, email delivery, marketing, analytics, fraud detection, event management services, promotions, sweepstakes, contests, and surveys).

**Financial Services Companies.** Companies that check your credit and offer financing for your purchases, such as Klarna, if you choose to use them. Klarna may use your information in accordance with its privacy policy.

**Payment Processing Companies.** Any payment card information you use to make a purchase through the Services is collected and processed directly by our payment processing providers, such as PayPal. PayPal may use your payment data in accordance with its privacy policy, available at <https://www.paypal.com/ca/webapps/mpp/ua/privacy-full>.

**Advertising Partners.** We may share your personal information with third-party advertising companies for the interest-based advertising purposes described above.

**Professional Advisors.** Professional advisors, such as lawyers, accountants, auditors, bankers, and insurers, where necessary in the course of the professional services that they render to us.

**Authorities and Others.** Law enforcement, government authorities, courts, and private parties, as we believe in good faith to be necessary or appropriate for the compliance and protection purposes described above.

**Business Transferees.** Relevant participants in business transactions (or potential transactions) involving a corporate divestiture, merger, consolidation, acquisition, reorganization, sale, or other disposition of all or any portion of the business or assets of, or equity interests in, Groupe Dynamite Inc. or our affiliates (including in connection with a bankruptcy or similar proceedings).

**Business and Marketing Partners.** Third parties with whom we co-sponsor events or promotions, with whom we jointly offer products or services, or whose products or services may be of interest to you.

**Third-Party Platforms.** If you choose to log into the Services with, or otherwise link your Services account to, a social media platform such as Facebook, we may share your personal information with that third-party service. The third party's use of the shared information will be governed by its privacy policy and the settings associated with your account with the third-party service.

## **6. What Are Your Rights?**

Depending on the jurisdiction in which you are located, you may benefit from different rights over your personal information, such as:

**Right to Information and Access:** You have the right to be informed about how we collect, use, and disclose your personal information. You also have the right to access the personal information we hold about you.

**Right to Rectification:** If you believe that any personal information we hold about you is incorrect or incomplete, you have the right to request its correction.

**Right to Erasure:** You can request the deletion of your personal information under certain circumstances and depending on your jurisdiction. Please note that this right is not absolute and may be subject to specific exceptions under the law.

**Right to Data Portability:** You may have the right to receive your personal information in a structured, commonly used, and machine-readable format, and you may have the right to transmit that data to another entity without hindrance from us.

**Right to Object and Withdraw Consent:** You have the right to object to the processing of your personal information under certain circumstances and to withdraw your consent to the processing of your personal information at any time.

**Right to Non-Discrimination:** You have the right not to be discriminated against for exercising your privacy rights.

**Right to Lodge a Complaint:** If you believe that we have processed your personal information in

violation of applicable law, you have the right to lodge a complaint with a competent supervisory authority.

To exercise these rights, please contact our Privacy Officer. Please note that we may ask you to verify your identity before responding to such requests.

## **7. Your Choices**

You have the following choices with respect to your personal information:

**Access or Update Your Information.** If you have registered for an account with us, you may review and update certain account information by logging into the account or communicating with our Privacy Officer if you have further concerns.

**Consent and Marketing Communications.** We will only collect, use, and disclose your personal information with your explicit consent. You have the right to give, refuse, or withdraw your consent at any time. Specifically, for marketing communications, we will only send you these communications if you explicitly opt in. You can do this when you create an account with us or by contacting us at [customerservice@dynamiteclothing.com](mailto:customerservice@dynamiteclothing.com).

If you later decide you no longer wish to receive these messages, you can unsubscribe from marketing-related messages by using the applicable self-service unsubscribe procedure (for example, by clicking an unsubscribe link in an email, replying STOP to the short code or telephone number from which text messages are being sent, adjusting your website user account preferences, or contacting us at [privacy@dynamite.ca](mailto:privacy@dynamite.ca) or at 1-888-882-1138). From time to time, Groupe Dynamite Inc. may use your personal information to communicate with you regarding important matters, such as information about your purchases or updates to Groupe Dynamite Inc.'s Privacy Policy or the Terms of Use that govern Groupe Dynamite Inc.'s websites. Given the information's important nature, it is not possible for you to opt out of these communications.

**Cookies and Tracking Technologies.** You have control over your cookie and tracking preferences. Most browsers allow you to remove and/or stop accepting cookies from the websites you visit. To do this, follow the instructions in your browser's settings. Many browsers accept cookies by default until you change your settings. However, if you do not accept cookies, you may not be able to use all the features of the Services, and they may not work properly. **Local Storage.** You may be able to limit the use of HTML5 cookies in your browser settings. Unlike other cookies, Flash-based local storage cannot be removed or rejected via your browser settings, but you can adjust the settings of your Flash player to block it. Blocking Flash storage may impede the functionalities of Flash applications, including those employed by the Services. **Declining to Provide Information.** We need to collect personal information to provide certain services, such as your address to ship a product. If you do not provide the information requested, we may not be able to provide those services.

**Third-Party Platforms.** If you choose to connect to the Services through your social media account, such as Facebook, you may be able to use your settings in your account with that platform to limit the information we receive from it. If you revoke our ability to access information from a third-party platform, that choice will not apply to information that we have already received from that third party.

Please note that we may also work with companies that offer their own opt-out mechanisms or do not participate in the opt-out mechanisms described above. We have no control over those mechanisms and even after using these opt-out mechanisms, you may receive interest-based advertising from other companies.

## **8. Social Networking, Other Sites and Services**

When you use certain aspects of Groupe Dynamite Inc.'s websites or other services or post information to other social networking sites, there may be, for example, links to Groupe Dynamite Inc.'s Facebook or X pages or you may be able to "Like" a product on your Facebook account or "Pin" a product on your Pinterest account. The information that you post or share in connection with these third-party sites is visible to other persons and can be read, collected, used, and disclosed by other persons, including to send unsolicited messages. In such cases, you will be leaving Groupe Dynamite Inc.'s website and going to the third party's website. These links are not an endorsement of, or representation that we are affiliated with, any third party. In addition, our content may be included on webpages or in mobile applications or other online services that are not associated with us. Any information you provide or post to such third-party social networking sites and other sites is governed by their own privacy policies, which you may read on the applicable site. You are solely responsible for the information that you choose to post or share in those situations. Groupe Dynamite Inc. has no control over, responsibility for, or liability for the use, disclosure, and retention of the information that you disclose in those situations, and the use, disclosure, and retention of the disclosed information is not subject to this Policy. Please be careful when disclosing your information in those situations

## **9. Retention, Location and Security of Your Personal Information**

Groupe Dynamite Inc. retains your personal information for the period necessary to fulfill the purposes outlined in this Privacy Policy or a longer retention period as may be required or permitted by applicable law.

Groupe Dynamite Inc. will store and process your personal information in Canada. We may also store some information in other regions for specific services or functionalities that may require the transfer of personal information outside of Quebec or Canada, such as the United States and other countries.

When Groupe Dynamite Inc. must communicate personal information outside of Quebec, the Privacy team performs privacy impact assessments and uses contractual agreements with our service providers to ensure that personal information protection is granted in other jurisdictions. The laws of other countries regarding the collection, use, disclosure, and retention of personal information may be different from the laws of Canada. The disclosure of your information in accordance with this Privacy Policy may result in your personal information being transferred outside of Canada.
